Annual Bill Reminder

Groundwater Management Program bills were mailed out in August and are due 30 days from issuance. As a reminder, the annual fee is \$20 per domestic well or per acre-foot of permitted water rights.

GMP Fees fund a variety of programs for well owners, including financial assistance programs and conservation rebates and incentives.

Soak up the savings with conservation programs

Save water and help protect the groundwater aquifer with GMP assistance programs:



- **Water Smart Landscapes Program**

Get cash incentives when you convert grass to water-efficient landscaping, up to 2,500 square feet per property connected to a well. Save an estimated 55 gallons of water per year for every square foot of grass converted to water-efficient landscaping. Visit snwa.com for details.

- **Sub-meter Assistance Program**

Get a free one-inch meter (and a \$150 rebate to offset the cost of installation) to track personal water use and avoid over-pumping or fines.

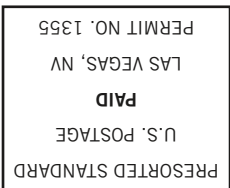
- **Well Conversion Grant Program**

Receive financial assistance—up to 85 percent of offsite construction costs and service connection costs—when you connect to the municipal water system.

- **Septic to Sewer Conversion Program**

Connect to the municipal sewer system and you could qualify for 85 percent of eligible conversion costs, up to a maximum benefit of \$40,000. Well owners are not required to convert wells under this program. For more information, visit snwa.com/rebates/septic-conversion.
